DURAND TOWNSHIP CEMETERY REFERENDUM

Shall Durand Township, Winnebago County, Illinois, be authorized to levy a new tax for cemetery purposes and have an additional tax of .20% of the equalized assessed value of the taxable property therein extended for such purposes?

(1) The approximate amount of taxes extendable at the most recently extended limiting rate is \$58,177.70 and the approximate amount of taxes extendable if the proposition is approved is \$148,761.50.

(2) For the 2009 levy year the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value at the time of the referendum of \$100,000 estimated to be \$67.00.

OWEN TOWNSHIP ROAD REFERENDUM

Shall the limiting rate under the Property Tax Extension Limitation Law for Owen Township Road District, Winnebago County, Illinois, be increased by an additional amount equal to 35 % above the limiting rate for the levy year 2008 and be equal to .1910 % of the equalized assessed value of the taxable property therein for levy year 2009.

(1) The approximate amount of taxes extendable at the most recently extended limiting rate is \$141,006.03, and the approximate amount of taxes extendable if the proposition is approved is \$191,023.00.

(2) For the 2009 levy year the approximate amount of additional tax extendable against property containing a single family residence and having a fair market value at the time of the referendum of \$100,000.00 is estimated to be \$14.57.

(3) If the proposition is approved, the aggregate extension for 2009 will be determined by the limiting rate set forth in the proposition, rather than the otherwise applicable limiting rate calculated under the provisions of the Property Tax Extension Limitation Law (commonly known as the Property Tax Cap Law).
